Program Details

The Curriculum

Each course in the HCC Certificate is three credits, totaling 15 credits.

- Introduction to the Legal System for Health Care and Compliance (3 credits)
- Legal Aspects of Health Care Compliance (3 credits)
- Effective Compliance Program Development and Skills (3 credits)
- Professional Judgment and Ethics, the Canvas of Compliance (3 credits)
- Selected Applications in Compliance (3 credits)

MSL Online Combined Programs

Students who successfully complete the Pitt Law Health Care Compliance Certificate may apply the 15 credits earned in the online program to the Master of Studies in Law (MSL) degree. This option allows students to earn both the certificate and the MSL in 30 credit hours. Students who completed the certificate program with a 3.0 GPA and decide to pursue the full master's program will be automatically considered for admission with no additional application or application fees.
